Wieland hosts Illinois Governor J.B. Pritzker at its East Alton manufacturing facility

On December 14th, Wieland, an industry leader in manufacturing and converting copper and copper alloys, hosted Illinois Governor J.B. Pritzker at its East Alton, Illinois facility.
